

Casitas MWD Weather Based Irrigation Controller Rebate Program

The goal of the Weather Based Irrigation Controller Rebate Program is to encourage reduced outdoor water use and promote healthy and attractive landscaping. A new generation of products are available that automatically adjust your irrigation schedule based on actual site and weather conditions. These controllers can prevent irrigation when it rains, apply more water to your garden during unexpected hot and dry spells, and automatically cycle/soak to reduced runoff from slopes. Controllers will also automatically adjust runtimes with the changing seasons. You save water, money, time and have healthier gardens and landscapes.

One study concluded that residents save more than 40 gallons per household per day after installation. Larger landscapes, like parks, colleges, and businesses save up to 400 gallons per day. Please note, significant water savings also depends on well designed and maintained landscapes.

REBATE AMOUNT: Up to \$250.00 toward the purchase of a weather based irrigation controller and sensor.

Eligibility Guidelines:

Please review the following program guidelines before proceeding further.

- Rebates are available on a first-come basis to eligible participants while funding lasts.
- Check your water bill to verify that you're a customer of one of the following participating
 water agencies: Casitas Municipal Water District; City of Ventura (located in Casitas District
 boundaries); Ventura River County Water District; Golden State Water Company; Sisar Mutual
 Water Company; Siete Robles Mutual Water Company; Senior Canyon Mutual Water
 Company; Rincon Water & Roads Works; Old Creek Road Water Association; Hermitage
 Mutual Water Company; Meiners Oaks County Water District; Sulphur Mountain Road Water
 Association; and Tico Mutual Water Company.
- The controller installation must occur on a landscape with a minimum of 2,000 square feet of irrigated landscape.
- New controller must be installed on fully operational, in-ground irrigation system with a preferred minimum of four valves/zones.
- There is a limit of one (1) weather based irrigation controller rebate per customer.
- To be eligible for a rebate, your new controller needs to be on the "Makes and Models List." Note: The current list is subject to change at any time.
- This program is not retroactive, only products purchased and installed after February 1, 2008 are eligible for a rebate.
- The rebate program is not responsible for materials lost by mail.
- Participants must agree to a post-installation inspection upon request.
- Rebates may take 8 to 16 weeks to process.
- Applications must be fully completed.

- Rebates may only be applied to the qualifying irrigation controllers when purchased and
 installed with a weather sensor or weather signal. They may not be applied to installation or
 signaling fee costs (if applicable). Please note some qualifying irrigation controllers require an
 annual signal fee to transmit weather information to the controller daily. Other qualifying
 irrigation controllers do not require an annual signal fee, but do require a weather sensor in
 addition to the qualifying irrigation controller.
- Total rebate amount will not exceed the receipt amount for irrigation controller and weather based sensor.

Instructions:

- Purchase qualifying weather based irrigation controller on "Makes and Models List" and install it on property.
- Install equipment according to manufacture's specifications. Professional installation is recommended but not required.
- Mail a copy of water bill, original sales receipt or purchase invoice and completed application within 60 days of installation to:

Privacy Notice:
