OLYMPUS PAINTING IN THE AMOUNT OF \$69,716.78 FOR ROOF REPAIRS

ON THE OAK VIEW TANK #2

RECOMMENDATION:

It is recommended that the Board of Directors authorize the General Manager to sign a change order in the amount of \$69,716.78 with Olympus Painting due to differing site conditions

BACKGROUND AND DISCUSSION:

As part of the Oak View Reservoir re-coat and repair project, the roof of the tank is proving to be especially difficult to blast free of rust and mill scale. The contractor has had a tough time achieving the necessary surface preparation for the application of the paint. The contractor has had to spend a longer time blasting which has resulted in additional costs that were not considered in their bid. The amount of effort is above and beyond what was specified in the bid documents.

A summary of the change in work is as follows:

Staff has contacted a paint manufacturer's technical representative to determine if there are alternatives to removing all of the rust. The technical representative replied that coating failure was far more likely if the roof was not blasted clean. Based on the square footage cost of the Ojai 4m Reservoir roof, the Oak View Reservoir No. 2 roof would cost about \$420,000 to replace completely. With minor exceptions, the roof is structurally sound.

Staff believes that the contractor has, in deed encountered differing site conditions, and should be entitled to collect additional monies for his additional expenses.

The FY 2010-11 Budget allocated \$391,185 for the coating and repair work.

The Board awarded a contract to Olympus Painting in the amount of \$280,540. In addition, a separate purchase order was requested in the amount of \$78,621 for Flex Tend couplings needed to partially seismic retrofit the tank. The remaining budget amount is \$32,024.

The amount needed to cover the deficit would be approximately \$38,000. The roof vent will also need to be replaced but this can be purchase separately and installed by Casitas personnel. The new roof vent will be approximately \$5000, for a total additional budget amount of \$43,000. It should be noted that several Capital Improvement projects have come in under budget and could be used as a source to fund the requested Change Order.
