The formulas for calculating the above attendance figures derived from the daily cash reports are as follows:

<u>Visitor Days</u> = Daily vehicles + 30-minute passes X 3 + café passes + attendance at special events + annual vehicle decals + replacement decals + campsites occupied +extra vehicles X 4

Camps = Campsites occupied + extra vehicles

<u>Cars</u> = Daily vehicles + 30-minute passes X 3 + café passes + attendance at special events + annual vehicle decals + replacement decals + campsites occupied + extra vehicles

<u>Boats</u> = Daily boats + overnight boats + annual decals + replacement decals

Kayaks & Canoes = Daily kayaks and canoes + overnight kayaks and canoes + annual kayaks and canoes

The month of June was the first full month of operation of our new Mega Play Unit (MPU) at the Water Park. Attendance during the week was down due to inclement weather, but the weekend attendance began increasing towards the end of the month. The annual Wine Festival was held on Saturday June 17th, there was a drop in pre advance tickets, but tickets sales were higher on event day. Rotary Club personnel believe the inclement weather could have played a part in pre-tickets sales. There were no issues reported for this event. This was the final year of the Rotary Club's Wine Festival agreement with CMWD, but they have indicated they wish to discuss options for a new agreement. LCRA staff will meet with Rotary Club personnel as early as August.

The American Bass Association (ABA) held two fishing tournaments in June with a total of 21 teams. There were 458 vessel tags issued and 23 vessels scheduled for inspection, with 7 passing, 7 failures, 5 cancellations or no show and 4 rescheduled. The monthly night fishing from the shoreline was held on the first weekend of the month.

Maintenance continued to prepare for the summer season by mowing grass, trimming trees, and completing bathroom readiness. The Turbidity curtain at Ayers Creek was dragged over to the shoreline by LCRA maintenance staff and pulled up onto shore by O&M staff. The two remaining Turbidity curtains will be removed during the offseason.

Casitas Water Adventure's Lazy River and MPU have been in operation for over a month with no major issues. It took a tremendous amount of teamwork from Operations, Water Park, and Human Resources, to reach our goal and successfully hired the needed number of lifeguards for the Summer Season. This is our first full season with both parks open in four years, and with several new lifeguards there will be ongoing training during the season.









Revenue Reporting

The year end fiscal total for the FY 22/23, were higher from the prior FY 21/22. The fiscal figures are unaudited and reported when made available for the respective months (operations, concessions, Casitas Water Adventure, etc.) per the District's Financial Summary, generated by the Chief Financial Officer.
