Recommendation:

Background:

The Committee asked that a request to the County of Ventura be considered for the posting of 'No Parking' signs along Santa Ana Road in the vicinity of the entrance to the Lake Casitas Recreation Area.

Discussion:

Currently, only vehicles are charged an entrance fee for admission to the Lake Casitas Recreation Area (guests that enter on foot or by bicycle are not charged).

This results in guests that do not want to pay the vehicle entrance fee, parking outside the park, often along a shoulder area along Santa Ana Road.

Current signage in this area of Santa Ana Road prohibits parking from 9PM to 7AM to prevent overnight camping along the shoulder.

<u>Boats</u> = Daily boats + overnight boats + annual decals + replacement decals

Kayaks & Canoes = Daily kayaks and canoes + overnight kayaks and canoes + annual kayaks and canoes
