Minutes of the Casitas Municipal Water District Board Meeting Held March 28, 2018

A meeting of the Board of Directors was held March 28, 2018 at the Casitas Municipal Water District located at 1055 Ventura Ave. in Oak View, California. The meeting was called to order at 3:00 p.m. President Word led the group in the flag salute.

1. Roll Call

Directors Baggerly, Bergen, Hicks and Word were present. Director Kaiser was out. Also present were Michael Flood, Assistant General Manager, Rebekah Vieira, Clerk of the Board, and Attorney, John Mathews. There were one staff member and 14 members of the public in attendance.

2. <u>Public comments</u> (Items not on the agenda – three minute limit).

Angelo Spandrio spoke to the board stating the three sisters plan is not simply hooking up to the state water project. The three sisters plan is an expansion of the Ventura plan. Richard Hajas is qualified to generate such a plan. He has been involved in planning, funding, design and build water resource projects in the county. I studied the three sisters plan and financial analysis in detail using my assumptions I validated Richard's conclusions and charts. Financial analysis shows nominal cost increases. City of Ventura is taking care of their own water security. Ventura is installing new 30 inch dimeter pipeline where needed in case Lake Casitas goes dry, and they have their wastewater recycling program. Their water future looks rosy. Calleguas hired Kennedy Jenks to evaluate options throughout eastern Ventura County. They are being proactive. We want our water agency to be proactive. I suggest you immediately enter into a contract with Kennedy Jenks to study bringing state water to Foster Park with the three sister plan. It needs to be done now. Meet with the other two sisters. If you don't have the time or expertise then hire a consultant to do it. There is opportunity to assist Calleguas in their quest for additional storage. You need to show Calleguas that the three sister plan is the best alternative. Get the plan out of its current pigeon hole.

3. <u>General Manager comments</u>.

Mr. Flood said that agenda item 10 will take care of my comments.

4. <u>Board of Director comments.</u>

Director Baggerly commented that when Richard Hajas was here making his presentation afterwards the discussion by board members said a feasibility study was a good idea. We put that concept on the state water ad hoc committee. Ideas for consultants include Corolla, AE Com, Larry Walker and Associates MWH Global and Stantec. An economic study for these projects needs to be done and I would like that to go to the finance committee. People seem to forget that Casitas is very much involved with intertie project, which is phase one of the three sisters project. The Notice of Preparation has been released for public review. Send comments to City of Ventura, Project Manager Betsy Cooper at 501 Poli St. Ventura, CA. Comment period ends March 30. You should read the notice of prep for EIR that might be done later this year for the intertie. We are also not just sitting around waiting for the EIR to be completed. We have the hobo project that could produce a conservative level more than half or more of our annual water usage for the district. 8,000 AF of water. Possibility of another well and a concept of desal for deep water wells in the Ojai basin. We are working to develop local water to be independent from an unreliable state water project. We need to be resilient and on our own dime when we can't get that state water. It does not mean the three sisters project is the only game in town. We need to make sure we fix our web page. People can't find the info they need.

Director Hicks added regarding diversions if past history holds true we divert every five years. That concerns me. People of Ojai get people excited, until we have to stop letting the water out for the fish. I'm really worried about our situation and my opinion is this lake will go dry if we keep doing what we are doing.

5. <u>Board of Director Verbal Reports on Meetings Attended.</u>

President Word attended the AWA meeting on quagga issues. It sounds like they are having difficulty in getting permitting agencies to agree on what they can or can't do. We met with Calleguas and city of Ventura and they are both fully aware of our interest and desire to participate. They are aware of what we need to make a connection that will work sending water east and west. Their time table does not end at June 1st. We have talked to both of them and they are very encouraging for us to continue the way we are working to work out the details and a feasible plan that will work long term.

Director Baggerly reported on his March 15 attendance with Jim and the General Manager to the CEQA scoping meeting for the notice of preparation for EIR for the Intertie. On the 16th I attended the Supervisor Bennett cooperation committee. Steve gave a good presentation of what Casitas is doing and how we are preparing for this water shortage emergency. Cooperation was evident.

President Word requested to discuss Item 14 d outside of the information items.

Mr. Flood reported that financial issues, reduced water supply and additional water supply are continuing to be discussed and meetings will be ongoing with Calleguas and the City of Ventura. Director Baggerly added I think that we need to try to help people understand what the administrative process is like for government. I'm getting emails that say please adopt the three sisters project now. That is not the way it works. There is an entire process and it takes time. There is the notice of preparation of the draft EIR for Calleguas, Ventura, and Casitas State Water Intertie. We cannot adopt a project without the EIR. A lot of work has been done by Kennedy Jenks to develop the EIR. More investigations will be done and then public hearings will be held on the project. The City of Ventura is the lead agency. There will be a public hearing and everyone will have some sort of presentation on the environmental document. We can't move ahead out of sequence. We want to do it right.

President Word added when we met with Calleguas and City we are pushing to move forward as quickly as possible. They acknowledge that we have participated for over a year and a half to work out the details. Flow studies are being done to move water east and west. It is still up to the city of Ventura and Calleguas to pull these forward. They still are key players in this. It depends a good part on what they want to do. They want to work with us and be as fair as possible. Both are interested to have a supply of water available for emergency use and reliable water.

A member of the public stated that the drought has been going on for six years. Understand what you are saying. Director Baggerly added we have been in this process for a year and a half. Director Bergen added in our meetings with Calleguas and Ventura there is a willingness to work together and good understanding that the East/West connection goes all the way to Casitas. We will cover the extra part to get it to Casitas. We have to define the hydrology and capacities, review the project and alternatives and then get to the costs. We have to have the project defined and it is in process.

Greg, a member of the public said I understand things take time. It would be helpful if there was some transparency with charts and diagrams and accountability to deadlines. Where are we with the Hobo's? What are the steps to get it done and who is responsible with the target dates. Can there be specifics and timelines and hold people responsible for hitting those targets. If we get the web site improved there is some document or charts give accountability and responsibility. Who is responsible? How do we get that out of all of the projects rather than trusting. Director Baggerly added we are not the lead agency but we can get some links from the city on our site.

Larry Yee of the Ojai Water Advisory Group stated the three sisters plan captures the essence of a regional cooperative assistance plan. Pool the resources in order to provide for more secure water future. Recognize the plan is complicated. State water is one part of the plan. A critical part. For you to solely focus on state water part of that plan. President Word interjected stating I take exception that the only thing we are looking at is the state water project. Mr. Yee responded the only part of the three sisters project is the state water. Before we sent it out to the other entities we sent it to Steve Wickstrum a week ahead of time. We were willing to make revisions based on Steve's input but received no response from Steve. Then we sent a notice out via email to Russ and Steve requesting a meeting to sit down and discuss and received zero response. That is no way to run a public agency. The WAG group has been meeting since last May. We met every other week, 1-2 hours at each meeting. I went to the Water Resources committee yesterday and of the 45 minute meeting you may have spent five minutes of talking about our future. There is a lot of concern and even anger coming your way. They do not know what you are doing. There has hardly been any response to us.

Director Hicks stated I would disagree with you. I organized with Mike Anderson a year ago to hook up with state water. At a meeting in Ojai a year and a half ago 300 people were there and there was a lecture and asked how many hook up to state water. Myself and one other guy raised our hands. Mr. Yee stated the state water project is one part of that plan. To say we take the state water as the first step or first stage and wait until that is settled. Think how to develop a cooperative future.

Maria Lucas, homeowner explained that a real estate agent said you are going to stage 4 and we have missed the boat in selling your house. People are fleeing Ojai because of water. It is very adversarial. Could we figure ways out to work on this together? We have some good ideas. The biggest problem is the community thinks what the future of the water is different than charts the district is giving us. From a homeowner we are scared to be stuck in Ojai, lose our homes, lifestyle and community and orchards. I am upset about it and see that we are sitting here and not in agreement at all in the fundamentals. If we could come together and agree on that then maybe we can work together better. Start on graphs on future of our water. If we can agree on fundamentals and go over the three sister plan together. We believe this is our best hope for our future.

Maybe this is a state of emergency. Think we have to work better together. I don't see that today. You are working and we are working together. Director Baggerly responded that the WAG group wants us to concentrate only on their project. Ms. Lucas said can we start with the assumption of what the water future is. Have an underlying assumption on what the urgency is.

Director Baggerly agreed that we all need to listen better. All I hear back from the community is to adopt the three sister plan. Phase 1 has been a year and a half in the process. We are not the lead agency. We are doing what we can. The state water project is integral to the three sisters project. No one wants to listen to what we are doing or understand how long it takes to get through a process. The city of Ventura is the lead agency for the first step of this process that we have been in for a year and a half. Ms. Lucan added that the assumptions of the community and your data are not in sync.

Mr. Mathews added this was an information item. Comments could have been done in public comments. Not sure this is the proper place to do it. Director Baggerly responded that we need to have this discussion.

Eugene Rooke explained that he has spoken with a number of you and Mary, you called me back. I disagree with a number of things you have said. Mary you were elected in 2010. You have been here a long time. You had a long time to take action. The drought in this area has been around. Director Baggerly said I do not accept that. Mr. Rooke added you say the hobo project could supply half of the water but Jordan Kear, your consultant says it is only to be an emergency water supply, not a regular water supply. Fracking is an art. You can't only talk about what you need in phase one. You have to talk about all three phases. You have to have an agreement that this is the deal. I have not heard any support of the three sisters plan. Who is authorized to negotiate a deal? When are you going to stand up and be counted to support the three sisters plan? If you don't support it say it. Other districts won't take you seriously.

Robin Gerber, Ojai resident thanked Mr. Hicks for the invitation to activism. I agree we need to know what you are doing, who is authorized and how the whole plan is moving forward. This is a failure of leadership and it starts with your general manager. I ask you how are you directing that person and making sure Mr. Wickstrum is doing his job? This is a transparency issue. Communication is a big problem. The anger you are hearing is because we don't know what is going on. Who is in charge, what is being done and where are the timelines.

Greg Shrogue challenged board and staff to take the leadership position and have us help behind. Director Hicks said we tried and called NMFS and they said no. That is what we are dealing with. They don't see any other view than their own. Mr. Shrogue suggested starting early enough looking towards next year and have the community help.

Barb Rugo of Ojai agreed with the other speakers. There is a sense of urgency. We are scared and read about Captetown. There is no timeline here and no sense of urgency. We have been in drought for six years. It is time to step on the pedal.

Director Baggerly added all of you should realize the state water project intertie is the three sisters project first step. We are already doing what you want us do to. The project is on its way. The Ad hoc committee is in discussions with the city and Calleguas, that is taking place. A member of the public suggested why not make Richard Hajas your consultant to bring your heads together rather than butting them.

10. General Manager's comments regarding March 2018 diversions.

Mr. Flood explained that the storm came in a couple of pulses. The first one was moderate with muddy water going down and running through the screens and diversion and gave water to fish and the canal. The second pulse was much stronger and that brought down a lot of debris which plugged the screens. We were out there working 24/7 to clean the screens off and restart start it and they would plug again. We contacted Rick Bush at NMFS and Mary Larson at CDFW. The response from Mary was we cannot pull screens to divert water. This event was nature's response to a catastrophe in the watershed and we will continue to deal with it as we have in the past. Usually we would not put this water into diversion. We will continue to work with regulators and work toward a better design. Those would be redesigned screens and possibly traveling screens. Travelling screens tend to harvest fish. All in all we got only a portion of the water down the canal. Santa Ana and Coyote creeks provided a lot of water into the lake with the turbidity screens doing their job. The storm brought us in total about 2,500 acre feet. That can take care of a portion of our evaporation in the lake this year. We would like to see more but that is probably what we have for now. President Word added to pull the screen has some negative consequences. Mr. Flood asked for the public patience as well as there is usually a reason why there is no water in the canal. President Word thanked staff for manning the facility 24/7.

11. Recommend negotiation of a one year exchange of State Water Contract Table A Water between Casitas Municipal Water District and San Gorgonio Pass Water Agency. APPROVED

Mr. Flood explained that the district normally will sell its water to the turn back pool which allows us to sell to State Water Contractors. Pool A was \$35/AF and the second pool was \$17/AF. Water goes to all of the contractors. We use the sale to reduce the tax roll. The City of Ventura has been working with San Gorgonio to do a transfer or exchange. They take the water this year and pay costs to get water to them and on reverse a certain amount of water needs to come back. 40% return of water in a future year. For the one year transfer it is \$1.5 million to the city. In talking to the city as well as considering our own

options, this is a good proposal to bring to the board. Director Baggerly added if we had taken advantage of turn back pool money it would lower the tax obligation, is that true of this transfer? Mr. Flood explained that has not been decided yet. There are costs with the State Water Project in searching out water security plans.

Minutes of the Casitas Municipal Water District Board Meeting Held April 11, 2018

A meeting of the Board of Directors was held April 11, 2018 at the Casitas Municipal Water District located at 1055 Ventura Ave. in Oak View, California. The meeting was called to order at 3:00 p.m. President Word led the group in the flag salute.

1. Roll Call

Directors Baggerly, Kaiser, Bergen, Hicks and Word were present. Also present were Steve Wickstrum, General Manager, Rebekah Vieira, Clerk of the Board, and Attorney, John Mathews. There were three staff members and six members of the public in attendance.

2. Public comments (Items not on the agenda – three minute limit).

Laurel Moore, owner of Azu in Ojai addressed the board expressing her concerns as a terrified business owner who could be looking at three-four years from now we will be out of water. I have not heard of any plans other than we hope it will rain and fill up our lake. This is my first time here and I think this is the beginning of a huge amount of merchants that don't want to see their businesses turn into dust in the next four - five years. I don't want to see business or real estate investment collapse. I am anxious to see what you have planned.

Eugene Rooke, Ojai resident addressed the board stating your main water source is Lake Casitas. You are still operating using a 2004 plan largely written by Steve Wickstrum. The plan assumes more water than we have. 40 inches of rain per year is unrealistic. We need more water, not just increased drought restrictions. You are not transparent. You don't say specifically what you are doing. Estimates I made from your newsletter and your data. Steve Wickstrum said to the Ventura County Star in November that he is often asked how long will it be until the lake goes dry. We, your customers, are doing our part. Demand has been reduced by 40% to 12,000 AF last year. You supplied that demand. Groundwater was 1500 AF and the balance was from the lake. Annual take from the lake, I'm tired of hearing it depends. Your original target was 18,000 AF/year. We will be at stage 4 drought in October and that is 14,000 AF of water, Stage 5

is 12,000 AF per year. 2011-2016 drought years average take was 20,000 AF per year. Are you going to turn off people's taps? How many years are left? The last newsletter said there was 70,000 AF in the lake. Minimum pool is 1,000 AF. Working with 70,000 AF, in October divide 18,000 12,000 or 20,000 into 70,000 AF and you get 4-6 years until lake is dry. I will use five. What happens when lake goes dry? You have 1,500 from groundwater supply to meet 10,000 af demand. You have five years until you can meet 15% of your demand. Your time is running out and you are not doing much. It is a question of survival and the impact of actions and inactions. Our home values, businesses and agriculture. You hope for rain. You have a big problem and you are not acknowledging it or taking responsibility for it. You are not doing your job and you hope we won't realize how bad things are. Some say you are pursuing sources. I don't believe it. The HOBO is no solution. It is an unknown emergency supply. You only just authorized an ad hoc committee. Last march you said Ventura is the lead agency. Ventura rejected your scope of work you wanted to pipe water to casitas. What negotiations are under way with the other districts to arrange other water sources? You chose not to participate while Calleguas and Ventura are working together. Casitas, what I don't understand is why are you satisfied that Calleguas and Ventura will have water and you want to go it alone. Engage and find someone dedicated to find other water supplies, promote Casitas participation and to negotiate on your behalf with your approval. Engage to find new water supplies. You demonstrated what you are doing now is not working. There are no new water supplies. We need active leadership that reports to the public. Hire someone – just do it. Your five years are counting.

Angelo Spandrio read the following. The Brown Act says in part that "...government bodies subject to the requirements of the Brown Act must provide public notice of their meetings, post agendas of the subjects to be discussed at those meetings, and provide public access to those meetings." One of your board members recently said that: "At the last meeting we were limited by the Brown Act which requires that items for discussion be on the agenda." I would very much like to see changes made to the way future agendas are composed. Items concerning our water future should be regular items on your agenda.

- 1. This will allow board members to discuss the future of our water, present motions and vote on those motions.
- This will allow the public to be prepared to discuss specific agenda items concerning their water since public interest in this subject is rapidly growing.

I would like to see the following 5 subjects specifically placed on each future agenda:

- 1. HoBo Project Status
- 2. State Water Project Ad Hoc Committee Report
- 3. Drought declarations and modifications to the WEAP Mr. Wickstrum has said that we can expect lake storage to decrease by around 13,000 AF

over the next 6 months or so leading to a State 4 Drought Declaration in October. Stage 5 is 10,000 AF later.

- 4. Ojai System:
 - a. # of wells on line and flow rates in each
 - b. Depth to water in those wells
 - c. Status of well refurbishment
 - d. Condition of the distribution system in Ojai
- 5. Search for other water sources such as the Ted Moore connection.

For each of the above subjects, the person(s) most versed in the subject should present the status, present the future action items to be taken and solicit discussion/guidance from the board. An occasional statement "NO REPORT" may be the report...

When I say that the above subjects should be specifically placed on the agenda, I'm speaking of them to be placed on the agenda in such a way to promote discussion/decisions among the board members, allow the Board to give the General Manager direction to promote public involvement. The above subjects should not be buried in agenda items such as General Manager comments, Board of Director comments, Board of Director Verbal Reports on Meetings Attended, Consent Agenda or Information Items.

Please, let's see these changes incorporated with all future agendas until our water worries are over.

Maria Lucas asked for an update every week. I don't feel any reassurance. As a homeowner I am freaked out.

3. <u>General Manager comments.</u>

Staff has met with Mustang Industries to develop the website for water security which should be completed by end of April. We will update it with items going on presently. The notice of CEQA documents on the intertie that Casitas, Calleguas and Ventura have been involved with since 2016. As it happens information will be posted.

The San Gorgonio Pass agreement will move to the County Board of Supervisors on Tuesday at 11:00 to get the letter of non-objection to move forward with the City of Ventura and ourselves. He requested that President Word be in attendance.

On April 16 we will be hosting United Water Conservation District to visit the Robles Fish Passage facility. They will be educated on what we have. There are major changes to be made at Freeman Diversion.

Chautauqua is this Sunday at 3:00. I provided some information to assist Randy Tillman to answer a lot of questions that have been asked as to what has been going on.

We have been waiting for Forest Service FS 299 permit to do an exploratory well in the forest service area. We also are looking at a vertical bore for Matilija Formation. The formation has the potential of producing 2,000 – 8,000 AF per year. Until we put drill into ground we will then know what we have available in the Matilija formation. We also met with Congresswoman Julia Brownley's office on Monday regarding the lack of action of the Forest Service to issue the FS299 to put data gathering equipment into springs and weeps to gather data and monitor how the formation performs in its water supply. We have been waiting for almost six months and the concern I have is the FS 299 to drill a hobo might take longer. We can look at drilling straight down directly on Casitas property. We will gather a cost estimate and bring back to consider as a project to move forward. It will probably take a month to a month and a half.

Mr. Wickstrum then reported that we are finishing up with the fire disaster with FEMA and will be cleaning out our duct system which is a reimbursable project.

Mr. Spandrio asked if it is possible to comment on the General Managers comments. He said I am confused about the vertical bore. How are we getting to Matilija sandstone from a vertical bore on Casitas property? Mr. Wickstrum explained the purpose is to see if it is there. We are relying on a Geotech expert who feels that it is there. Trying to access that formation directly below Casitas property and not rely on approvals and federal delays. What if we can't get into the forest service area? The vertical option is drawn on there on the original plan, one drawn straight down as another option if we get hit with someone not wanting us to go into the Forest Service.

Mr. Rooke added one reason you drill horizontally is to get more production. How thick do you expect this formation to be when you drill straight down? Mr. Wickstrum agreed about drilling diagonally and this does not seal off doing the hobo. We could get our analysis going and then on with the FS299 and do the hobo. You don't know until you drill. Mr. Rooke said until you understand the geology you can't say there is 2,000 - 8,000 AF there. You don't know if there is enough pressure to drive water to surface. Mr. Wickstrum added you don't know until you drill. A lot of wells are drilled that don't give anything. If we get one that gives us some info then it readies us for the hobo. Both options may be very beneficial on what we are doing. At that location we have the canal within 100 – 200 feet and about 7,000 feet away we have a 24 inch pipeline where we can treat and put into it into the system. This location looks to be the best place to start. Director Baggerly added suppose that vertical test works and we get water out of it. Then we can tell how the Matilija formation is acting to that extraction of water and serve as environmental review for the hobo. President Word added we will try all we can try, nothing ventured, nothing gained.

4. <u>Board of Director comments.</u>

Director Baggerly asked for a status of the shoreline growth permit removal. Mr. Wickstrum said it has been sitting with the Corp of Engineers office for some time. Director Baggerly asked about the Ojai System status. Mr. Wickstrum replied we have held meetings regarding modeling and projects. Director Baggerly then suggested the use of Lake Casitas Improvement Foundation to accept private donations to assist in funding water security projects. Mr. Mathews said he will have to look into this. Director Baggerly then mentioned a status report he wrote as a draft to be reviewed by committee and brought back as a status report. He added that a PR campaign is critical and we want to get information out there.

Director Hicks mentioned Met's decision to do the state water project alone with dual tunnels. Mr. Wickstrum added it is \$11 billion dollars for the dual tunnels for 9,000 cfs. The remainder of State Water Project Contractors will be handed a bill for the rest of it. We have been in talks for three years for a contract extension agreement to extend the contract to 2085.

Ms. Moore stated she didn't feel better. Director Baggerly suggested she take a copy of what he had written and read it as it goes over what we have been doing. A member of the public said you are trying to work to get a permit and this is why we are so concerned with the valley.

Mr. Wickstrum mentioned the OBGMA 2017 report on their website and recommended reading it as it provides information on where the city of Ojai gets their water. Another item that people forget is that they have water below their feet. That will get you a sense of where your water is coming from and the status of the basin that serves the city of Ojai. Director Baggerly added the basin has 65,000 AF. City of Ojai residents and business utilize this past year about 1,500 acre feet a year. Another 2,500 AF is pumped out for Ag in the east end of Ojai. The groundwater basins are in better recovery state than Lake Casitas.

Mr. Spandrio suggested that Jordan said 60% which puts it at 48,000 AF. Director Bergen added there is water there that in an emergency status will keep business in place. Mr. Spandrio added the sustainable yield is 5,000 AF per year. It is misleading to say 48,000 feet of water as accessible to the Ojai valley. The Ojai basin is not a simple tub. Mr. Wickstrum responded saying let's not say the city of Ojai has run out of water. That is the position that is being put out there that people are concerned. Director Kaiser added the public deserves to see information and see propaganda and emotions. There is a groundwater basin and from the report it is not being fully utilized as it could. Every time it rains there is replenishment. President Word added that we are finding out the condition of wells after the takeover of the Ojai System.

Mr. Rooke asked the board if the wells in Ojai will only supply the city of Ojai and not Oak View. Are you saying the city limits of Ojai have exclusive

rights to that water? President Word responded that is not what we are saying. Mr. Rooke responded that will spread throughout the valley and people like her will go out of business.

Director Baggerly added the Act of 1991 states no water shall be exported from the Ojai basin perimeters unless it is considered surplus. Mr. Rooke asked are you going to restrict that water to just for the city of Ojai. Director Baggerly added all the users overlay the Ojai basin. Mr. Wickstrum added this is where the rumors get spread. Mr. Mathews added that we would love to have this discussion on wells at some other time.

President Word moved the meeting to closed session at 3:50 p.m.

RECOMMENDATION:

Approve unbudgeted upgrade to the network connection between LCRA and the District Office in the amount of \$19,659.10 and monthly service fee increase of \$359.00 for 50 Mbps. This upgrade would transition the LCRA network to the fiber optic system that the District is currently utilizing at the District Office. This upgrade would allow sufficient band width to perform vital business tasks at LCRA.

BACKGROUND AND OVERVIEW:

An internet connection with a larger bandwidth can move a set amount of data much faster than an internet connection with a lower bandwidth. Bandwidth is typically expressed in bits per second, (60 Mbps to explain a data transfer rate of 60 million bits (megabits) every second). The network that is currently installed to connect LCRA to the District Office and the internet is operating at 1.5Mbps and unreliable by industry standards.

Installation of fiber optic will be able to transmit up to 1000 Mbps of encrypted high speed data which will allow the streaming of online safety training for LCRA staff, account for less down time of the online reservations and time clock systems that LCRA utilizes and increase overall productivity.

The network bandwidth used to connect the LCRA to the District Office and the internet is insufficient for regular operations and requires upgrade due to:

- 1. Unstable Line Connection to the District Office.
- 2. Low Network Speed.

SUMMARY

Upgrading to the fiber optic network connection will correct the unstable network connection to the District Office and the low network speed experienced by LCRA. It will also allow for more productivity, less down/wait time, allow for online streaming training and includes AT&T maintenance of the fiber optic lines between the District Office and LCRA.

RECOMMENDATION:

 Recommend the Board approve a budget of \$5,775.00 for removal and inspection of the Ojai Water System Mutual Well #6.

BACKGROUND:

Mutual Well #6 is part of the water supply within the Ojai Water System. Recent issues with the well necessitate the removal of the submersible well pump, inspection of the pump, and a videolog of the well. Details of the issues with Mutual Well #6 are as follows:

- 1. Production has dropped off from 300 GPM to 200 GPM over the last few months while water levels have gone up and production of the other Ojai Water System wells in the vicinity have increased.
- 2. Drawdown is about 75' while other wells average about 175'; suspicion is that there is an issue with the submersible pump.
- 3. The pump will be pulled and inspected and the well videoed to its full depth (about 510').
- 4. Staff will return with recommendations.
- 5. Price is \$5,775.00 which doesn't include re-installation (that will be part of any repair quote).

RECOMMENDATION:

It is recommended the Board of Directors accept the proposal submitted by the lowest responsive and responsible bidder and award the contract for the Lake Casitas Recreation Area and Water Treatment Plant Road Maintenance, Specification 18-399 to BC Rincon Construction, Inc. in the amount of \$56,350.35. It is further recommended the President of the Board execute the agreement for said work and the Board authorize staff to proceed with the administration of the contract.

BACKGROUND AND DISCUSSION:

Lake Casitas Recreation Area

Annually, staff reviews the condition of roads within the Lake Casitas Recreation Area (LCRA) and determines where the limited repair funds should be expended. This year's project includes road reconstruction along a portion of the main road between Campground F and Lake Side Group Camp which has experienced increased degradation and potholing. The budget for this portion of the project is \$25,000 and is eligible for a 50% match through a US Bureau of Reclamation grant.

Water Treatment Plant

Road maintenance at the Water Treatment Plant (WTP) typically occurs every five years. Oxygen deliveries for the hypolimnetic aeration tank located at the top of the Casitas Reservoir dam has resulted in increased heavy vehicle traffic and subsequent road degradation. This year's project includes road reconstruction along a portion of Vista Point Road, along with extending an existing asphalt berm to prevent scouring along the road's edge. The budget for this portion of the project is \$40,000.

The project was advertised through F.W. Dodge and on the District's web site. Four firms submitted proposals. The bid results are as follows:

Date: April 20, 2018

RECOMMENDATION:

It is recommended that the Board of Directors authorize the purchase of the Allen-Bradley Modules and PLCs in the amount of \$8,750.21.

BACKGROUND:

The Casitas Municipal Water District is continuing to improve and integrate the Ojai Water System. The Electrical/Mechanical staff has identified an immediate need to replace existing modules and PLCs to meet the standards of the District, work toward SCADA integration, and avoid a system failure. Staff is requesting the approval of out-of-budget purchase of six power supplies, seven Allen-Bradley 4-chanel analog and five Allen-Bradley Micrologix PLCs, in the amount of \$8,750.21.

The purchase is supported by the General Manager and has been reviewed by the Finance Committee.

RECOMMENDATION

It is recommended that the Board of Directors authorize the General Manager to execute the attached Application for Federal Assistance SF-424 and enter into an Assistance Agreement with the United States Bureau of Reclamation for \$499,739 in matching grant funds for Recreation Area facility repairs and improvements.

BACKGROUND

Since September 28, 2011, Casitas Municipal Water District's Lake Casitas Recreation Area has had active cooperative agreements with the Bureau of Reclamation for quagga mussel protection and recreation facility improvement and maintenance. Grant number R11AC20123 totaled \$931,748.00 in grant funds, grant number R15AP00006 totaled \$400,000 and this grant totals up \$499,739 pending the ability of the Bureau of Reclamation to fund. Each grant is for five years.

Projects completed since the inception of the grants include: road improvement, repairs and maintenance; Casitas Water Adventure repairs and maintenance; Picnic 8 overhead replacement; a Boat House; maintenance carts and mower; the front gate overhead project including kiosks and security cameras; playground surface replacement and repairs; and the invasive species prevention program including staff time for all aforementioned projects.

ANALYSIS

All projects and activities funded by the grant require prior Board approval for implementation through the competitive bid and/or budgeting process as in, for example, staff time for invasive species prevention, cables and tags. The scope of the new grant includes road repairs and maintenance; picnic surface replacement; a vessel inspection station shade awning; illuminated exit directional signs at the main gate; and the anti-invasive species program.

The Bureau has been supportive of the Lake Casitas Recreation Area by providing grant funds for infrastructure and the invasive species prevention program.

The General Manager asked for a review of three cost proposals that have come to the attention of the General Manager. The three proposals are for the installation of AT&T fiber optics to the Lake Casitas Recreation Area in the amount of \$19,659.10, the extraction and inspection of Mutual Well # 6 pump in the amount of \$5,775, and the bid proposal for asphalt work at the Lake Casitas Recreation Area in the amount of \$56,350.35. RE: County of Ventura Action to Approve a Bona Fide Water Exchange

Date: April 18, 2018

RECOMMENDATION:

It is recommended that the Board of Directors receive and file this memorandum.

BACKGROUND:

During the regular meeting of the Casitas Board of Directors on March 28, 2018, the Board authorized the initiation of the one-year bona fide exchange of the Casitas State Water entitlement to the San Gorgonio Pass Water Agency (SGPWA). The City of San Buenaventura authorized a similar action for a bona fide exchange with SGPWA. In accordance with the 1971 Agreement between the County and Casitas, this out-of-County exchange of water must receive prior approval of Ventura County and the State.

On April 10, 2018, Casitas and Ventura Water met with Supervisor Steve Bennett's office to request a consideration of a non-objection letter that would provide the prior approval for an out-of-County exchange. Supervisor Bennett understood the timely nature of the action and agreed to set this item on to the next regular meeting of the Board of Supervisors. Supervisor Bennet authored the attached letter and the "Reasons Expressed for Not Obstructing the State Water Allocation Transfer" for consideration by the Board of Supervisors. The Board of Supervisors considered the request for prior approval on April 17, 2018, and unanimously approved the request with a condition that the water agencies work together to resolve differences of opinion regarding such out-of-County bona fide exchanges.

The representatives from the United Water Conservation District (UWCD) expressed a position of non-objection to the action, UWCD did express that this water could be used in-County to address current shortfalls of water supply and lessen the economic impacts in Ventura County resulting from water shortages. UWCD requested that the County condition the approval by asking for more cooperation between the three water agencies. UWCD original argument was clarified that the exchange does not prohibit UWCD's access to Article 21 water, should it become available in 2018.

I pointed to the difficulty in delivering State Water to Ventura County under the current conditions of insufficient infrastructure, indecisions in the past by UWCD to obtain as much State Water as was made available, and the concerns over the spread of quagga mussels from Lake Piru. Ventura Water general manager Kevin Brown stated that he had asked if UWCD would also like to participate in the exchange.

In a parallel path, the State Water Contractors reviewed the proposed exchange on April 16th and will move forward a recommendation for a final approval by the Department of Water Resources (State). The exchange contract between all agencies will move to our respective governing bodies once an approval is received from the State.

DISCUSSION:

Normally this letter would come from the staff of the Public Works Agency, but it is time sensitive and to expedite placement of the item on the Board agenda. Ventura requested that I bring this letter forward.

There will be some parties who object to this one-year State Water Project allocation being acquired by an out of county agency. Before and at our Board meeting, I will present a list of reasons why it is appropriate that we not object to Ventura and Casitas MWD doing this. I apologize that the short notice I received on this does not allow me to offer that list as I file this letter.

I am optimistic that we will, as is our custom, all keep an open mind as we have a full discussion of this issue. The essential background information I can give you now is the following.

In 1963, the Ventura County Flood Control District (VCFCD), now the Ventura County Watershed Protection District, entered into an agreement with the State of California to obtain a 20,000 acre-foot per year (AFY) entitlement to State Water Project water. Multiple subsequent agreements transferred and assigned portions of the 20,000 AFY entitlement to and between various other water agencies in the county. The 20,000 AFY entitlement is currently divided between the Casitas MWD, Ventura, and the United Water Conservation District (United Water currently leases out a portion of its allocation).

While the three agencies must pay significant sums annually for their State water entitlement, none of the three agencies have pipeline connections that enable them to receive State water. The agencies have regularly sold their unused allocations through the State Department of Water Resources sale pool to recover some of the annual cost of their entitlement. United Water has sometimes received its entitlement via streambed release from either Pyramid or Castaic Lake, and has on occasion purchased some of the other agencies' allocations for this purpose.

For 2018, Ventura and Casitas MWD have entered into agreements, approved by their City Council and Board, to transfer their unused 2018 entitlements to the San Gorgonio Pass Water Agency. The terms of these agreements provide both substantially higher remuneration to Casitas MWD and Ventura, and contain a provision that gives Ventura and Casitas MWD the ability to recover up to 40% of the exchanged water over the next ten years. These terms make this a far more beneficial arrangement for those agencies, their ratepayers, and the region as a whole than the previous sales through the State pool. Additionally, Ventura and Casitas MWD have indicated that the additional revenue will assist with furthering a joint project with the Calleguas Municipal Water District to establish a mutually beneficial regional interconnection of their water supplies.

Amongst the many transfer and assignment agreements pertaining to VCFCD's original 20,000 AFY entitlement, a 1970 agreement between VCFCD and the Ventura River Municipal Water District (VRMWD), now Casitas MWD, states that "No assignment or commitment of the water referred to in this contract shall be made by VRMWD to any agency outside of Ventura County without prior approval of VCFCD and STATE." In order to assure that the 2018 agreement between Ventura and Casitas MWD and the San Gorgonio Pass Water Agency may proceed unimpeded, Ventura and Casitas MWD

have requested that the Ventura County Watershed Protection District sign the attached non-objection letter regarding the transfer of their 2018 allocation to San Gorgonio.

This item has been reviewed by the Public Works Agency Director and County Counsel.

Reasons Expressed for Not Obstructing the State Water Allocation Transfer

- -The County long ago transferred its State Water Allocation to the Casitas MWD and City of Ventura. The County could have retained control but chose to instead transfer it to others. This transfer also transferred the financial responsibility for the annual allocation payments.
- -For the past 48 years, Ventura and Casitas have been paying the annual cost of their State Water Allocation. Currently, Ventura pays \$2.1 million/year and Casitas over \$1 million for water they cannot access.
- -Ventura and Casitas are sovereign local governments with elected board members who have a fiduciary responsibility to their voters and ratepayers.
- -the Casitas Municipal Water District is not within the United Water Conservation District and does not receive any water from the Santa Clara River groundwater basins. Providing Casitas' allocation to United would be of no benefit to the Casitas water supply.
- -The City of Ventura only draws a small portion of its water from Santa Clara River Basins. Providing Ventura's allocation to United would be of only slight benefit to Ventura and would primarily benefit others outside the city.
- -Ventura and Casitas do not have any duty to provide resources to United, nor does any other city or water district (beyond paying United's standard fees)
- -The cities of Oxnard and Camarillo, and Waterworks District #1 all have State water or financial resources that they could potentially provide to United. None do.
- -Similarly, the cities of Santa Paula and Fillmore pump all of their water from aquifers in the United district but do not provide resources to United. Nor do mutual water companies, water districts, or private pumpers.
- -United's attempt to argue that Ventura and Casitas have a special duty to provide resources to United is not based in law nor consistent with any established practice. United has not provided any evidence of a duty on the part of Ventura, Casitas, or any other city or district to provide resources to United.
- -Ventura and Casitas, and sometimes United, have been selling their annual allocation on the State pool for many years and could do so in 2018. Water sold on the state pool goes out of the county.
- -United can also buy water through the State pool.
- -United could buy transferred State water allocations from around the State in the same manner as the San Gorgonio Pass Water Agency.

- -United could potentially provide financial incentives to the cities of Oxnard and Camarillo and Water Works District #1 to draw more State water and pump less groundwater, thereby achieving the same net effect of increasing the local supply of State water and conserving groundwater.
- -Ventura and Casitas have sometimes successfully negotiated an allocation transfer to United, and sometimes the attempted negotiations have been unsuccessful.
- -Both Ventura and Casitas have expressed a willingness to sell/transfer their 2018 allocation to United, but it would be contrary to their fiduciary duty to make their ratepayers absorb a substantial financial loss in order to do so.
- -It would be inappropriate and unwarranted for the Board of Supervisors to intervene to obstruct the lawful allocation transfer by Ventura and Casitas for the financial benefit of United.
- -It would also be counterproductive for the Board to intervene because the San Gorgonio transfer terms are far more beneficial locally and regionally than sale in the State pool. The San Gorgonio terms: a) provide the ability for return of up to 40% of the water in the next ten years, and b) provide needed financial resources toward the regional water interconnection between the Calleguas MWD, Ventura, and Lake Casitas.

Three sisters: Two agencies in proposed water plan expressing reservations



Three ideas for solving the area's water shortage were explored at the Ojai Chautauqua's "Panel on Water in the Ojai Valley" April 15.

One of the concepts, the Three Sisters Proposal, was presented by the Ojai Valley Water Advisory Group's (WAG) Richard Hajas.

Under the plan, Casitas Municipal Water District (CMWD), Calleguas Municipal Water District and the city of Ventura would work together to create the ability to pipe in water from the State Water Project (SWP).

With Ojai attached to the SWP, Lake Casitas could then recharge and become storage for reduced use and emergencies.

The plan also was discussed at the March 8 meeting of the Upper Ventura River Groundwater Agency (UVRGA).

The Board considered urging CMWD to immediately start negotiations with Calleguas and Ventura to pursue the ideas in the WAG report.

Ventura Water general manager Kevin Brown explained that talks were already under way between Calleguas, Ventura and Casitas, and he thought the recommended action was unneccesary.

Brown also disagreed with some of the concepts in the Three Sisters Proposal.

Board member Mary Bergen, who represents CMWD, agreed with Brown that the UVRGA action was unnecessary.

"Things are already happening. Casitas is already working to access the SWP," Bergen told the Ojai Valley News.

But Bergen supports state water.

"I'm all on board for that, but we need to see what the costs are. We're optimistic we can make it work," she said.

UVRGA boardmembers were unable to come to a consensus, so no action was taken.

Hajas said as far as he knew the only action taken by Casitas to access the SWP was to contribute funding for some of the preliminary design and environmental work for a pipeline between Camarillo and Saticoy.

"They (Casitas) have taken no official position on the Three Sisters Proposal," Hajas told the Ojai Valley News.

CMWD general manager Steve Wickstrum said there's no quick fix to the water shortage.

"We all live this and we're trying to work through it," he said. "We have some opportunities that will help us get on the SWP and we have opportunities to access groundwater."

Wickstrum attended the Chautauqua as an audience member.

"It was a good forum to express your views and to find out what's going on," he said.

The other two proposals discussed at the event were the horizontal bore (HoBo) project to tap into groundwater north of the lake, and a proposal to redesign rain catchments and systems to directly recharge aquifers.

"The almost ubiquitous feeling I heard from people is they think that the agencies aren't being urgent enough," said Ojai Chautauqua event manager Andy Gilman. "They're feeling more urgency than they're seeing, and that's what they want to change."

Casitas looking to drill deep well as alternative to horizontal plan

Casitas Municipal Water District (CMWD) officials have announced a new path they will likely take to help mitigate impacts of the current drought.

They're exploring the possibility of drilling a vertical bore (or VerBo) to tap into an aquifer in the Santa Ynez Mountains west of Ojai.

The well would be drilled to a depth of 6,000 to 7,000 feet.

"This would be a very deep well, not something like the 300-foot wells people drill around this area," said Steve Wickstrum, CMWD general manager.

The idea is a spin-off of the horizontal bore (HoBo) concept first proposed by CMWD directors in 2016.

Wickstrum presented the VerBo plan to the CMWD Board of Directors at its regular meeting April 11.

"This is an exploratory well, to see if we can determine water quality and the availability of water," Wickstrum told the Ojai Valley News. "If it shows good water quality, and if there's an ample water supply, then we move on to stage two."

The drilling site would be in essentially the same spot proposed for HoBo, on CMWD property north of Lake Casitas near the Robles Diversion Facility.

"We'd have this and HoBo drawing water from different directions — two outlets in the same location," Wickstrum said.

Another advantage of the project site is the pipeline nearby that CMWD could use to distribute the water

Unlike the HoBo project, that would drill under U.S. Forest Service (USFS) land, VerBo would operate on CMWD land only.

The project would not require permit approval from the USFS, which, for HoBo, "is taking an exorbitant amount of time," Wickstrum said.

USFS District Ranger John "Pancho" Smith confirmed that permit approval for HoBo will be a long, step-by-step process that could take two years to complete.

Environmental watchdog group Los Padres ForestWatch submitted a letter to Casitas in 2017 outlining its concerns about HoBo.

Those concerns included the potential to deplete surface water supplies and damage forest ecosystems.

CMWD is now taking bids to drill the exploratory VerBo well.

"It's now a matter of cost," Wickstrum said. "We should know something in about a month." How much will the VerBo cost?

"It's not an inexpensive project," said Wickstrum, who put the price tag in the \$1 million range. Wickstrum hopes to have the proposal before the Board for its last meeting in May or the first meeting in June.

Exploratory drilling to look for good water could begin this summer, he said.

"Is there a risk you don't find it? Yes, but if you don't try, you don't know," Wickstrum said. Some of the evidence of water in the Matilija sandstone comes from the strong flows encountered by crews digging water tunnels in the Santa Ynez range in the 1950s.

According to hydrogeologist and groundwater consultant Jordan Kear, the aquifer could provide an estimated 8,000 acre-feet per year to Lake Casitas.

Kear believes the current reserve of water in a six-mile section of the Matilija Formation could be upwards of 87,000 acre-feet.

During wet years, Kear expects the aquifer to recharge at a rate of approximately 2,000 acre-feet per year.

More research to refine the estimates is underway, according to Kear.

"Of critical importance is that the VerBo is still an emergency measure, and would not be used in earnest unless certain drought thresholds were met," he explained.
