Minutes of the Casitas Municipal Water District Board Meeting Held July 27, 2016

A meeting of the Board of Directors was held July 27, 2016 at the Casitas Municipal Water District located at 1055 Ventura Ave. in Oak View, California. The meeting was called to order at 3:00 p.m. Directors Kaiser, Baggerly, Word, and Hicks were present. Director Bergen was absent. Also present were Steve Wickstrum, General Manager, Rebekah Vieira, Clerk of the Board, and Attorney, John Mathews. There were five staff members and two members of the public in attendance. President Kaiser led the group in the flag salute.

1. Public Comments (items not on the agenda – three minute limit).

Bruce Kuebler, Director of Ventura River Water District expressed concern about drought and the lake going dry without access to water. He urged the board to connect to regional water access to supplemental supplies that might be available.

President Kaiser added we all need to work together on this to look at contingencies available and discuss the costs that come in to play. The public will fill in the gaps with reactions. No information begets concern. It is important we all work together to fully investigate in a post haste manner. Director Word added there is no easy answer and it will take an effort on all of our parts to come up with something that will work. President Kaiser added that we can hope for rain but hope is not a plan of action.

Randy Haney Ojai City Councilmember thanked the board for what they have done and the actions regarding Golden State. The City of Ojai is thankful. He explained that he is here to talk about water and relayed an analogy of the water shortage being a football game. When the lake is at 100% full it is the start of the game. All is good when have a full body of water. In the first quarter we lost a little water and life is good. At half time 50% of lake is down, we are not winning. As a coach we adjust at half time and make changes on what we can do better or differently. Now we are at 39%. In 14% we will be in third quarter and losing. Are we going to wait until the game is over to make another adjustment? Half of the game is over, we have to dig in and figure this out. He explained that he had contacted local and state representatives and suggested holding a summit to have all the players together and bring everyone together to solve problems. He concluded by thanking the board for all they do and what they will do.

2. <u>General Manager comments.</u>

Mr. Wickstrum informed the board of his discussion with the City of Ventura and the County to begin to coordinate efforts to bring in state water and ensure we have county assistance. Tully Clifford indicated the county would provide assistance in bringing the pipeline in. A meeting was also held bringing together water managers from Ventura River and Meiners Oaks and Ventura

Water. We had lunch at the lake and discussed new opportunities for state water connection. There are new opportunities and now we have the potential and try to move forward as quickly as possible. There is emphasis on the decline of the lake for the last 11 years. There was talk about coordination of efforts and financial aspects. It is a western Ventura county problem. All parties need to commit to securing water supply. It is not as easy a solution as a seven mile pipeline. Things are proceeding in that avenue.

3. Board of Director comments.

Director Hicks mentioned a meeting with 13 individuals including seven engineers and two previous City managers where they discussion the drought and possibility of state water. In the past there have been 15 – 20 year droughts. Mr. Wickstrum explained there has been a game plan. Part of that was you don't play a sloppy game in the first half. Conservation is no longer involuntary. We hope we see the lake refill but we will not return back to sloppy play in the first half. There is a real effort by the public and state to retain these changes in California. The WEAP provides us with flexibility to make changes during continued drought.

Director Word added it is encouraging that we are seeing folks other than those of us that deal with it day to day be aware of the shortcomings and potential disaster. The public is starting to grasp that idea. We have to get the public involved. It is not an easy or inexpensive solution but we have to deal with it. Director Baggerly added the game is afoot. People are working on new water sources and new solutions. President Kaiser added no game is won if the team is in status quo. The Executive committee agenda has an item to look at a workshop coming up and to consider how we expand to other agencies locally to work together. We are endeavoring to move ahead on this expeditiously.

Director Hicks reported on his attendance at the AWA Water Issues meeting where United gave a presentation on their GSA. He added that Met is seeing a return on their investment with their turf removal program. During high heat in July last year they sold 7,000 acre feet/day and this year are now selling 5,000 acre feet/day.

RECOMMENDATION:

It is recommended that the Board of Directors adopt the resolution accepting the proposal submitted by the lowest responsive and responsible bidder and award the contract for the construction of the Robles Fish Passage Facility-Diffuser Modifications, Specification 16-389 to Irwin Industries, Inc. in the amount of \$53,500. It is further recommended that the President of the Board execute the agreement for said work and the Board authorize staff to proceed with the administration of the contract.

BACKGROUND AND DISCUSSION:

The Robles Fish Passage Facilities has diffuser (baffle) panels behind the fish screens and diffuser (baffles) within the auxiliary water system. The fish screen cleaning system has been able to keep the fish screens clean the last few times there were significant diversion flows. However, the diffusers behind the screens have clogged. There is no easy way to clean the diffuser panels.

The auxiliary water system provides attraction flow water to supplement the flow in the fish passage. Flows up to 121 CFS should pass through the auxiliary water system. To date, Casitas has not been able to document flows of 121 CFS through the auxiliary water system.

The solution for both the clogging of the fish screen diffuser panels and flow through the auxiliary system is to have diffuser panels with larger openings. This project will replace the existing 1/4" round hole perforated plate with 1/2" square hole perforated plate.

The project was advertised through F.W. Dodge and on the District's web site. Two firms submitted proposals. The bid results are as follows:

Irwin Industries, Inc. has completed several similar projects for Casitas in the past. Irwin Industries, Inc. has a current and active contractor's license, a satisfactory safety record and a current DIR registration number. The FY 2016-17 Budget includes \$120,000 to complete this work.

This project is categorically exempt from CEQA under Section 15301. The proposed modifications have been approved by the USBR and NMFS.

<u>Boating</u>

There were 12 cables sold for new inspections, 5 vessels were re-inspected and a total of 566 vessels were retagged. Four vessels failed the first inspection in June 2016. With the historic drought and receding water levels the launch ramp at Santa Ana no longer could accommodate vessel launches and exits, so the 1961 Old Coyote ramp has been successfully put back in use.

Operations

The Trout in Classroom program successfully released trout into Lake Casitas with the oversight of a Park Services Officer. Thirty children from six classrooms accompanied their teachers for the release on June 4. Free events such as astronomy night and movie night have had good attendance with the exception of a June 25 astronomy night that had an unusual occurrence of zero in attendance. The annual Ojai Wine Festival was successfully held on June 12 with increased attendance over 2015.


Incidents

More often than not our customers who attend board meetings and public hearings from a variety of agencies ask the question "what are we going to do if the lake goes dry"? What are the water agencies putting in place to make sure we do not run out of water? Many of them are wondering what this will do to the housing prices and if they should sell their property now before it gets any worse. The questions are temporarily answered, but the customer leaves, not totally convinced that the issues are well in hand. This casts doubt upon us, as water professionals from our customer base, who pay us to find the answers to these questions.

On June 26, 2016, during Lake Casitas Water Resources meeting, the General Manager was presented a list of 18 different ideas to be approved at the August CMWD Board meeting. MOWD feels that all these options should be explored to the extent possible and would be happy to contribute to the reconnaissance team costs and supply them with any material necessary to complete the work.

Because CMWD is the back-up source of water for the Ojai Valley holding a State Water allocation, MOWD feels that is of the upmost importance that CMWD has a connection to a regional pipeline with the City of Ventura, Calleguas, and likely United Water to help ensure future water needs of the Ojai Valley.
